Cargo Tracking Device¹

Singapore Airlines Cargo now offers the option of placing cargo tracking device(s) with your shipment, which enables customer(s) to get real-time* updates. Please refer to the table below for the list of approved devices.

*Do note that cargo tracking devices are designed to suppress data transmission during flight

Booking/Acceptance

Cargo tracking device(s) used in shipment booked on SIA Group operated/marketd flights must be declared to Singapore Airlines Cargo. Special handling codes, **EMD** and **ELI/ELM**, must be reflected in the booking details with the following information provided in the handling information box on the Master Air Waybill and the SSR line of the FWB:

1. Model of device (e.g. Sentry 500),

MAWB copy Handling Information	Handling Information Field in FWB
SENTRY 500 LOGGER IN SHIPMENT	SSR/ SENTRY 500 LOGGER IN SHIPMENT

Kindly note that requirements and labelling in accordance to normal DG regulations for ELI/ELM shall apply to shipments with cargo tracking devices. Interline shipments containing cargo tracking devices cannot be accepted.
